

I have been a part of the 3 housing workshops in February provided by ILP. Each session was always filled with fun activities, great information, and prizes for the youth that attended. As a bonus, there were always snacks and drinks. For the first workshop, they set up a jeopardy game where the participants answered questions that were all related to housing programs and program jargon. The winners of the game won \$100! The next week, I helped facilitate a roleplay



game where the participants had information that was given to them to fill out a housing form as someone else. The idea was to have participants get familiar specific types of questions they'll have to answer and the types of forms used for housing applications. The prize for that activity was a pair of Beats headphones! The final session consisted of a person-to-person, black out bingo where participants went around the room and answered questions about themselves. The winner of that game received a prize of \$50 dollars! This workshop series was both fun and informative.

FINANCIAL AID NIGHT HIGHLIGHT

ILP INCOME TAX WORKSHOP

In February, ILP held an income tax workshop. This workshop was very informative and led by JBAY (John Burtons Advocates for Youth). They covered many subjects from filing taxes to different credits that you can claim, including the new foster youth credits. They also talked about JBAY's VITA sites. These are physical office locations all around the Bay Area where you can go to access JBAY services. These services include things like tax information, law services, housing support programs, and more. ILP provided computers for each person to file their taxes online. Every participant who filed their taxes were rewarded a \$50 Amazon gift card!

This event was informative and the space that was held for this workshop was very youth-friendly. The facilitators took time to answer any questions and made sure to ask for clarification to support the youth that attended. They even stayed after for any questions or in case anyone still needed help but didn't feel comfortable asking in the larger group. There was food and lots of active conversion that made the space feel welcoming and fun. This was a great workshop to be a part of and I hope to sit in on another session soon.

TAX INFORMATION & TIPS

Filing taxes is important because it allows you to calculate your tax liability, schedule, tax payments, or request refunds for the overpayment of taxes. One tip that is helpful to know about is your deduction on your taxes. A deduction is money you spent during the year for work, insurance, retirement, education, childcare, rent and more that reduces how much you pay in taxes and could help you get a bigger cash back refund. If you don't pay your taxes on time this can lead to a failure to file penalty. Meaning if you are due a refund, there's no penalty for failure to file. Any refund is used to pay any back taxes owed. This can involve the IRS, bad credit scores, and blocks on loans.

Here is a source to help support you file your taxes. The <u>Tax Prep Checklist</u> from John Burton Advocates for Youth, located at 235 Montgomery Street, Suite 1142 San Francisco, CA 94104. You can call them at (415) 348-0011 or email anna@jbay.org. They have great step-by-step tools and tips for filing your taxes. First, they recommend you have your personal information ready. Such as license, social, earning documents, etc. They are also offering eligibility for the Foster Youth Tax Credit worth up to \$1,083 in cash back. For this credit, you must do the following: File your federal and state tax return; check the circle stating yes you were in care on or after age 13; and check the circle to provide consent to confirm your eligibility with the California Department. Another source I recommend is Turbo Tax. It's a simple, easy, and accurate way to file your taxes online. They provide friendly expert support and offer a free version. This is a great tool available for filing taxes.


REGISTER FOR ILP SERVICES

Complete a <u>Request For Service (RFS)</u> form with a Worker of the Day (WOD) over the phone. Our Intake Coordinator will call/email you regarding your eligibility. It takes around 1-2 days to process your RFS form. Once contacted, you will virtually meet with an ILP Coach to discuss your needs, interests, and goals. Your coach will assist you with registering for workshops, activities, and any services that appeal to you!
